

The 21st Century Community Learning Centers Program Overview

The 21st Century Community Learning Centers (21st CCLC) serves as a supplementary program to enhance district-wide efforts to provide high quality academic opportunities to their student population. The 21st CCLC program assists students in meeting academic standards in core subjects (math, reading, science, social studies) by providing out-of-school time services to students and their families. It also provides enrichment opportunities to help students meet academic standards and graduate ready for college and/or the workforce. The 21st CCLC Program currently serves 28 campuses in the District.

Expected Outcomes

Critical Success Factors
