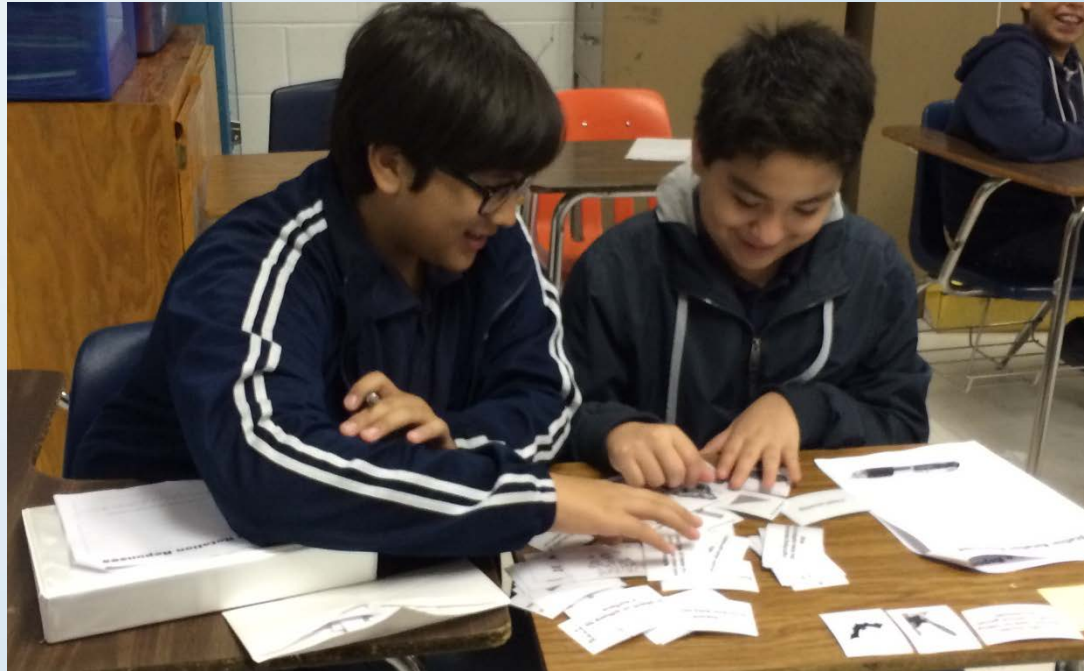

- Students who are NOT part of the cohort will complete the same paperwork but it will be titled Dual Enrollment.
- Deadline April 13, 2018
- Packet Review April 16-20<sup>th</sup> (2 middle schools/day) at CAB
