BACKGROUND:

On March 22, 2021, BISD Purchasing Department received and opened bid packages from five (5) vendors for CSP #21-134 Elementary Mini-Gyms HVAC and Restroom Addition, Group I project. On March 23, 2021, the members of the ranking committee evaluated the five (5) qualified vendors and selected Scoggins Construction Co., Inc. of Harlingen, Texas, which has received the highest-ranking scores and is recommended for the Construction Services. Administration recommends approving Scoggins Construction Co., Inc. for Construction Services at Elementary Mini-Gyms HVAC and Restroom Addition, Group I project in the amount not to exceed \$4,680,000.00. The construction project is scheduled to achieve substantial completion Two Hundred and Fifteen days (215) from the Notice to Proceed date.
